

Knights of Pythias Glencoe Lodge #22 – Pack 175 Agreement

The Annual Charter Agreement between the Knights of Pythias – Glencoe Lodge #22 of North Plains, Oregon (“KOP”) and Cascade Pacific Council (“CPC”) of the Boy Scouts of America (“BSA”) requires a chartered organization to conduct the Scouting program according to the sponsoring organizations’ policies and guidelines as well as the policies and guidelines of BSA. These are the policies and guidelines of the Board of Directors of the KOP for the Cub Scout Pack 175 of North Plains, Oregon (“Pack 175”) pursuant to that Annual Charter Agreement.

1. Each adult leader of the BSA, Pack 175 must complete a BSA Adult Application and successfully complete the BSA background check and BSA Youth Protection Training before he/she attends or participates in and Pack 175 activity that occurs between 10:00P.M. and 6:00A.M. or serves as a leader in Pack 175.
2. The Pack 175 committee chair shall provide the Charter Representative of KOP with a written copy of the official roster listing all registered adult members of Pack 175 and a written update upon such official changes.
3. Until the CPC informs Pack 175 and the KOP that the adult leader has passed the BSA background check, the adult registration is not active.
4. All adult leaders participating in any Pack 175 day or overnight activity shall refer to the BSA Guide to Safe Scouting for that particular activity prior to the event and shall comply with all the provisions specific to that activity, insofar as to not exclude any compliance to applicable sections or subsections of the BSA Guide to Safe Scouting related to the activity.
5. Only adult leaders who are currently registered may participate in any Pack 175 activity between 10:00 P.M. and 6:00 A.M.
6. At least one adult leader who is currently registered must participate in any Pack 175 activity between 6:00 A.M. and 10:00 P.M.
7. All adult participants in any activity shall comply with the principals and rules as set forth in the current edition of the BSA Guide to Safe Scouting.
8. Pack 175 will perform a financial / asset audit of its accounts each year and provide a written report on that audit to the Charter Representative of KOP.
9. The KOP may receive funds as an agent for Pack 175. If the KOP receives any funds for the benefit of Pack 175, KOP shall act as a trustee of any such funds, promptly deposit such funds in the checking account of the Foundation of the Knights of Pythias Lodge of North Plains, Oregon and forward such funds to Pack 175 promptly.

10. The Activities Chair of Pack 175, or other registered adult leader shall complete a current BSA Trip Plan worksheet for any overnight activity and whenever else required. The adult leader in charge of any overnight activity of Pack 175 shall sign the BSA Trip Plan worksheet and submit it to the CPC. At least two registered adults shall be present on any overnight activity of Pack 175.
11. The goal of these policies is to have a safe, educational and enjoyable Scouting program for BSA Pack 175. This agreement will be signed annually as long as the KP is the chartered organization for BSA Pack 175.
12. The terms “registered”, “registration”, “certified”, “participant”, “active” and “adult leader” herein have the meaning as defined in the BSA Guide to Safe Scouting
